END OF UNIVERSITY MODEM POOL EXTENDED TO MAY 20, 2005

The original date for the elimination of all University supported residential dial up modem pool service was scheduled for January 1, 2005. This date has now been extended until May 20, 2005 to provide additional time for faculty, staff and students to complete the spring semester before transitioning to a new service provider of their choice. Regardless of which service provider is selected, it will be necessary to install and use the Cisco Virtual Private Network (VPN) client to access certain network resources of the University.

On July 1, 2004 modem pool telephone lines were reduced from 408 to 192 lines. Since this reduction, modem pool use has continued to decline. A further reduction from 192 to 144 modem pool telephone lines will take place on January 1, 2005. On May 20, 2005 all modem pool telephone lines will be removed and the existing University modem pool will be shut down along with the 438-8210 modem pool access number.

UNIVERSITY POLICIES / PROCEDURES

1.1.12 STATE OFFICIALS AND EMPLOYEES ETHICS ACT (SOEEA)

Civil Service, Non-Exempt Employees

All Civil Service, Non-Exempt employees are required to submit time cards bi-monthly (the 15th or the last standard work day prior to the 15th and the last standard work day of the month). These time cards document time spent on official university business, as well as any leave time. Pursuant to the Act, this time must be reported on at least a quarter-hour basis. However, according to University policy, this time is reported to the nearest tenth-hour.

Academic/Professional and Civil Service, Exempt Employees

All Academic/Professional and Civil Service, Exempt employees are required to report leave time, which may include sick leave, vacation leave, or any other appropriately approved leave on a monthly basis on the Employee Benefit Usage card. Pursuant to the Act, this time must be reported on at least a quarter-hour basis. However, according to University policy, this time is reported to the nearest tenth-hour.

State Reviewing Pension Options

The Governor recently established a Pension Commission charged with recommending ways to address the State's severely under funded pension systems: SURS, SERS and TRS.

The commission is considering all options including decreasing the cost-of-living adjustment, cutting the interest rate credited to members' accounts, increasing the employee contribution, etc. According to James Hacking, executive director of State Universities Retirement System, such changes applied to current participants would constitute "a clearly unconstitutional diminishment of benefits." State Senator Bill Brady serves on this commission. Feel free to contact Senator Brady or other legislators to voice your concerns on this issue (see next column for web and email addresses).
