This law repeals the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO), both of which often reduced payable Social Security benefits those eligible for both Social Security benefits and SURS benefits. The law will apply to Social Security benefits payable after December 31, 2023. Neither Human Resources nor SURS can provide guidance on individual financial impacts based upon this law. For specific questions, please contact the Social Security Administration.
