- a. Ad Hoc Committees

v. Toys for Tots

- Beth Porter contacted Troy Zeigler, facility's staff member at the Steam and Power Plant, to see how the TFT collections are going. Troy said all is going well for this time of year. He and his volunteers have picked up several boxes around campus that have been filled up. He is heading to the Alumni Services today to pick up more full boxes. He expressed his thanks for getting the word out about the collection boxes.
- b. Civil Service Committee Representatives
 - i. Academic Senate (Quanisha Kumi-Darfour)
 - 1. The Academic Senate continues to consider revisions to the definition of plagiarism found in the Code of Student Conduct. These proposed revisions include references to content created by "generative Artificial Intelligence."
 - 2. The Academic Senate voted to delete policy 3.2.12 Ombudsperson contingent on the hiring of a University Ombudsperson employee. This person will receive complaints,

concerns, and inquiries regarding issues from faculty, staff, and students. It is worth noting that the current Ombudsperson Council only addresses faculty and staff issues.

3. The Academic Senate is considering a recommendation from the Honors Council to disband this external committee of the Senate. Although the University has had this Council for sixty years, its functions are now completed by other committees and groups across the University.

ii. AP/CS Staff Council Merger (Beth Porter)

 - a. Please also share this far and wide in the next 24 hours.
- 2. We had no one show up to the evening Merger Committee Roundtable in Oct, and only 20+ show up to the daytime Merger Committee Roundtable. Most were council members. We hope the promotion of the online survey will give us some more responses to get a more quantitative review of the support for the merger.
- Overall, from the few responses we have had there is support for the merger, with
 hesitation if it means we lose representation in the Senate and other committees. The
 Merger Committee also agrees that the merger should not diminish our voice and
 representation on campus.
- iii. Campus Communications Committee (Quanisha Kumi-Darfour & Justin Lawson)
 - 1. Change to representation 3-3-3.
- iv. Employee Advisory Committee/EAC (Christa Lawhun)-EAC chair addressed the merit board on our recommendations regarding the out of state requirements to test for employment. They are as follows: We recommend and would support the adoption of rules that would require,
 - 1. A qualified applicant to establish residency within 180 calendar days of any employment offer or final appointment and maintain residency throughout their appointment.
 - 2. That the residency requirement be waived if the applicant lives within a specified distance of miles, to be determined, from the agency in which the applicant is applying.
 - 3. The residency requirement may be waived for a small percentage of 1% or less, for a non-resident fully remote employee and require approval by the State Universities Civil Service System.
 - 4. That Illinois preference points, similar to veterans' preference points, be granted for qualified applicants who are current Illinois residents. The administration of these points should be outlined for the covered agencies by the State Universities Civil Service System.
