**Foundation** – Lin will prepare a proposal to gain voting rights on this committee. Question was raised about A. Goldfarb donating his raise to the Foundation. Where is it being used? Was it a one time donation or done annually? The Foundation Office notified us that we have an additional \$1,000 that has not been included in our Foundation account balance. Discussion was held regarding increasing the scholarships from \$500 to \$1,000. Is this additional \$1,000 a one-time addition or will we receive every year? Council will investigate whether this \$2,000 Foundation balance is permanent and are there limitations of amount of scholarship given by either CSC by laws or Foundation? Will revisit amount of scholarship after all questions are answered.

**By Laws** – Will look into reconfiguring number of representatives assigned to each group to reflect consistent ratios of group members to representatives. Council was asked to review the by laws which are located on the website.

**Campus Communications** – There will be a joint discussion with the Town of Normal Council held before the July 20, 2001 Board of Trustees meeting. It will be held from 8am-9:15am in the Circus Room at the Bone Student Center. This discussion is open to everyone.
