Civil Service Council (CSC) Meeting September 17, 2002

Martha Burk opened the meeting at Noon.

Jan Shane, Paul Borg, and Joe Rives were present to discuss the North Central Association (NCA) Accreditation. At this time they wanted to make us aware they are in the initiating process. The accreditation is done every 10 years. University is sound financially within the means of the State of Illinois, in shared governance, and student outcomes. The process is coordinated by the Provost and includes the whole campus. Self-study will be 2-3 years and look at what can we do to be even better to prepare for the 2005 site visit. The Civil Service Council will be a part of the University's NCA committee and meet with those conducting the site visit. NCA looks for active process and communication. They will ask if everyone had opportunity to be involved. The University wants to focus on 2 or 3 special projects from Educating Illinois. We expect NCA's formal approval for a "special emphasis review". The special emphasis review would focus on building faculty distinctiveness and excellence; partnerships for student learning; and coordinating, planning, budgeting and assessment at the University level.

- Q) What happens after Educating Illinois? A) It is a continuous planning process.
- Q) Does NCA do all colleges and universities? A) Participation is voluntary in the century old accreditation. We are in the largest region with 10 states in central U.S. and Arizona.
- Q) What if we are not accredited for 10 years? A) They may give 5 years with a report needed at end of 4 years to receive the remaining 5 years. If not accredited it is a black mark on the university and diploma may not transfer for advanced degree. We have had 20 years accredited and believe we are in good shape to be accredited for another 10. When we added Mennonite College we went through accreditation. Within the University we have 19 accredited areas.
- Q) 2 ½ years seems like a long time for self-study. A) Educating Illinois took 3 years.
- Q) When will we update Educating Illinois? A) In 2003. We will keep core values. We will be in strong position when NCA comes in.

The Steering Committee will occasionally contact us with updates. There will be lots of communication. The web site should be up in next 2-3 weeks. Distributed a list of steering committee members and description of proposed special emphases. They invite participation and welcome participation if we want to be a member of the committee; subcommittees will be formed in November and will need representatives. They will accept long or short-term commitments. The Council was asked to help identify those good for a committee. The committees will include 1 graduate student and 2 undergraduate students. Council members who are interested in being on the NCA committee should let Martha know. We thanked Jan, Paul, and Joe for their time in discussing the NCA Accreditation.

- 30 and Out As of today we have 94 employees with 30 or more years of service and 230 employees with 25 or more years of service.
- Reorganization Steve Bragg has announced effective October 1 Academic Personnel and Human Resources are merging and will begin reporting to Vice President for Finance and Planning. Mary Beth Clapp will no longer be involved with HR. A team will be working on the merger that is expected to take 6 months. Sue Zinck, Director of Academic Personnel, will lead the merger team. Human Resources is waiting for representative to be named for committee. An Acting Director or Assistant Director will be named. Physical location moves are not yet known. The merger should provide better equity by using similar process and sharing one philosophy. Martha will contact Steve Bragg concerning the importance of a Civil Service Council representative being named to the committee. Both staffs have been assured no layoffs are planned. - <u>Constituent Question</u> A constituent asked that the following questions be brought up for a response from the HR rep: Q) Charting absences to see if there are any trends should this be happening? A) A supervisor may track absences as set out in the University Absence Policy that addresses unscheduled/scheduled absences and trends in absences.
 - Q) What is the purpose of the office manager keeping copies of the timecards? Why does the supervisor need to tell the office manager the reason for absence? A) There should be a discussion with the supervisor to ask why and what they are used for. If there are few staff with these questions include them for a group meeting with supervisor.
 - Q) Some staff don't fill out an absence slip so their sick and vacation time is not used and they look better on the chart of absences. A) This could be due to some employees being non-exempt and others exempt.
