### **Committee Reports**

• Human Resources – Julie provided status of layoffs and bumping. Everyone has notice who would receive one. Some chose to bump and two currently on leave who will be bumping when they return, five changed percentage of position, and one retired. Less than 10 are without positions and were placed on the reemployment register. The average seniority was less than one year with some obscure classifications maybe more. Vacancies were allowed to be opened and filled. Although some vacancies were filled, in the big scheme of things, there were still cuts. Some departments were able to fund position while other could not. Concern was discussed about the first tier names kept very quiet and the second tier names are out there. Julie explained that it was not from HR, but staff speculated and spread names. Discussed constituent's concern about posting for new position of Assistant Vice President. This position will be a liaison between IBHE and ISU. It was posted the same as all positions are required to be posted. There is an appeals process in place for departments to appeal the decision to not fill a position. Since appeals are handled by the University President, Human Resources only hears of those approved after an exception to the hiring freeze has been granted.
