Martha and Paul gave their presentation "A Day in the Life of Illinois State University Staff" that they had presented to the Board of Trustees at their last meeting. With the help of various staff, they developed an excellent presentation which represents the diversity of staff at Illinois State University. The presentation highlighted staff at work in a variety of positions during a 24 hour day - Midnight to 11:59pm. Positions reflected front line personnel and the "invisible" personnel making up the infrastructure of the University. Some items noted that positions directly or indirectly effect student lives, a large number of evening hours are required for staff, some staff members are working up to 80 hours a week as a regular part of their jobs, the huge complexity of University, and the campus is a city. The Board of Trustees response was that of very interested in the information presented.
