**-Website Redesign Update** – Jacob showed a mock-up of the proposed new website for the CSC. Council members were asked to submit suggestions to B. Huonker prior to the March 2 meeting.

-Approval of Minutes – A motion was brought forward by J. Darnall and seconded by T. Sanchez to approve the Feb. 2 CSC minutes. The motion was approved.

**-Secure Storage Space for CSC** – B. Huonker is still waiting to meet with President Bowman for storage space for the CSC.

**-Cubs Trip** – The date for the Cubs game is May 27. This is ISU Day at Wrigley Field. The Cubs are playing the Dodgers. Tickets for the game this year will be \$18.00. This is \$6.00 more per ticket than last year. Chicago now has a 12% Amusement Tax. If the council charges \$40.00 per ticket for the bus trip and the game ticket, a profit of \$120.00 per bus bill be realized. A motion was brought forward by T. Sanchez, and seconded by C. Pfoff to charge \$40.00 for the ticket and bus trip to offset the increase in ticket prices this year. The motion carried.
