Due to continuing concerns expressed by the State Universities Retirement System (SURS), steps have been initiated to not display current and year-to-date employer paid benefits for SURS on pay advices, immediately.

SURS has informed Illinois State University the amounts displayed with disclaimer* in Message Section is misleading to employees and leading to SURS Administration being questioned.

*The State Universities Retirement System (SURS) employer-paid benefit amount reflects the contribution amount employers, Illinois State University, are required to pay to SURS for all SURS covered earnings if employee was paid from federal, grant, and trust funds.

For employees enrolled in the Self-Managed Plan (SMP), employees will need to utilize data on the SURS and Vendor sites to verify they receive appropriate employer contributions from SURS. The State of Illinois matches employee contributions at a rate of 7.6% of their eligible earnings. Of the 7.6%, 7.3% is applied to their SMP account and .3% is set aside for the disability fund.
