Frivolous Facts

Where's the world's biggest mint? The Philadelphia Mint, the fourth U.S. Mint in that city since 1792, is the world's largest mint, covering over 5 acres of ground. Almost 400,000 people visited it last year, breaking all visitor records.



How can you tell where a coin came from? Mint marks show what minting facility your coins came from—"P" for Philadelphia, "D" for Denver, and "S" for San Francisco. This mark can be found to the right of the subject's face on the obverse side of each circulating coin—with the exception of the "Philadelphia" Lincoln cent, which has no mint mark.

NEW COUNCIL LEGISLATIVE COMMITTEE

Legislative changes, on the state and federal level, affect all of our lives. A recent example was the state's plan to radically change our benefit choices. A state-wide protest prevented the plan from being enacted. In recognition of the importance of such civic involvement, the Civil Service Council has appointed a new Legislative Committee. The Committee's charge, formally adopted in June, 2005, is:

Civil Service Council Legislative Committee Charge

1. The Legislative Committee will monitor activities and pending legislation primarily in Springfield but also Washington D.C.
2. As a regular meeting agenda item, the Committee will bring concerns and information to the Council for review and discussion.
3. The Council will collectively determine what issues need further attention/action. Actions may range from contacting appropriate ISU administrators for input to writing letters to state or federal representatives.
4. Legislative Committee Members will submit draft letters addressing specific concerns to the Council for revision/approval to go to the next step.
5. Any final letter will be sent to the appropriate representative by the Council Chair on behalf of the Council.
