The 2011 SECA (State and University Employee Combined Appeal) Campaign kicks off September 13. This is the opportunity for Civil Service employees to contribute to the organizations of their choice from a list of more than 1,800 participating agencies.

You can give a one-time donation by filling out the pledge form and attaching your check made out to the agency or you can sign up for payroll deduction. The minimum payroll deduction is \$2.00 per pay

period. That equals about 2ϕ per hour. I challenge every civil service employee to double that to 4ϕ per hour or more. That is a small amount that can make a big impact!
